Textual Information(1)	a)The unaudited consolidated financial results for the quarter and half year ended September 30 2025, have been reviewed and recommended by the audit committee and approved by the board of directors of the Company at their respective meetings held on November 12, 2025. It has been prepared in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013 read with the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time. ' b)The Group is primarily engaged in providing integrated logistics services which is considered as a single business segment in terms of segment reporting as per Ind AS 108. The services are not rendered outside India. Hence, no separate geographical segments to be reported on. ' c)In accordance with the approved resolution plan, the Company has remitted the final installment, including the applicable interest, during the quarter ended September 30 2025. Additionally, the Company has received no objection certificate from major financial creditors, confirming that all terms of the resolution plan have been duly complied with post remittance. The interest on borrowings has been appropriately accrued under finance costs till payment of the final installment. ' d)Other income for the quarter ended September 30, 2025 includes profit on sale of land amounting to Rs. 2,854 lakhs in the Company. ' e)Figures pertaining to the previous periods have been regrouped, reclassified and rearranged wherever necessary.
