The interest on borrowings has been appropriately accrued under finance costs till payment of the final installment. 'd) Other income for the quarter ended September 30, 2025 includes profit on sale of land amounting to Rs. 2,854 lakhs 'e) Figures pertaining to the previous periods have been regrouped, reclassified and rearranged wherever necessary.
